## Application for Young Women's Summer Camp – July 30 - August 4, 2023

Camp Fully Involved is an intense, hands-on fire services camp for young women between the ages of 14 and 20, who are interested in a career in the fire service. Class size will be limited to 24 cadets in order to provide the safest, most interactive, hands-on program. Applicants not accepted into the 2024 program will be considered first for the 2025 program. Preference will be given to non-returning cadets. **Only COMPLETE applications will be reviewed and accepted.** Complete packages will include the cadet's application, 2 letters off recommendation, and a 500-word essay. Selection for the program is random, and no preference is given to applicants who may have fire service experience or affiliation.

Completed Application (page 1 ONLY), with appropriate signatures, postmarked by May 1, 2024 2 Letters of recommendation From adults not related to you (i.e., teacher, coach) 500 word essay titled

"Why I am interested in a career in the fire service"

All applications, essays, and letters of recommendation must be postmarked by May 1, 2024. Applications received after that will not be processed. Please **DO NOT** send payment for camp with application.

\*\* Transportation to and from the NH Fire Academy is the responsibility of the cadet unless the cadet will require air travel. If traveling by air, please attempt to fly into Manchester, NH (Manchester-Boston Regional Airport, MHT) or if needed, Boston, MA (Logan International Airport, BOS). CFI staff will be there to meet the cadet for transport to the NH Fire Academy.
